



### Superintendent's Message

As many of you know, this is my last year as superintendent of the Sherburne-Earlville Central School District. It has been my privilege to serve this great community in this capacity for the past six years. Your Board of Education is currently engaged in a search process to find my replacement. They have started the search earlier than most districts to insure a smooth transition of leadership and to reopen the search if they do not find a suitable candidate. I encourage you to keep yourselves informed of the process. Alan Pole, BOCES District Superintendent, is assisting the Board of Education in the search process. There are two committees comprised of community members, teachers, support staff, administrators, Board members, and students. These two committees will interview the candidates and provide input to the Board of Education who will make the final selection. I believe this is the most important decision that we will have to make this year. This new superintendent will be charged with continuing to move the district forward in the areas of academics and interscholastic athletics. We have been engaged in many new initiatives over the past six years such as heterogeneous grouping, raising our teaching and instructional standards, differentiated instruction, learner-focused classrooms, curriculum mapping, and a new block schedule at the Middle School. This is our third year in the Section III sports league, which has brought us new competition and rekindled some old rivalries that went back to the 1970's.

While the past has taken us a long way on our journey to prepare our students for the challenges of the future, the future needs of this district have to be assessed. Plans need to be developed on how to meet these needs, and there has to be an assessment of the effectiveness of our plans. This will be the challenge for the new Superintendent of Schools. While my retirement doesn't take effect until July 1, 2005, I want to take this time to say thank you for your support of me, but more importantly, thank you for supporting the

#### **Board Report**

As I begin this school year, my second on your school board, we face some significant challenges. This school board, with the valuable assistance of our administrators, teachers, staff, students, and community members, begins the process of selecting a new Superintendent of Schools. Dr. Steven Szatko will finish his educational career with us in June of 2005. There are two primary responsibilities that a school board has: developing school district policies and hiring a Superintendent of Schools. The school board has decided to follow the process used for the last superintendent search. We have retained the services of Mr. Alan Pole, Superintendent of DCMO BOCES, to help facilitate the process. The school board decided in May that we would be seeking a superintendent with emphasis on academic excellence who was sensitive to the community and dedicated to continuing our desire to provide the best possible education for our children.

The school board met on September 27, and finalized the candidates to be interviewed. Those candidates were interviewed by two committees of twelve members during the first round of interviews. The committees each were made up as follows.

The students received free admission as well as a free hot dog and soda. As far as I know, all students took advantage of the free food!


Students from ten other schools were invited. All the students were allowed to take a lap around the inside of the ball field. They were treated to a fireworks display after that.

- Student directory information includes: name, address, photographs, telephone listing, date, grade, place of birth, major field of study, participation in officially recognized activities and sports, weight and height (if members of athletic teams), and degrees and awards received.
- For purposes of press releases / public relations, only name, photographs, grade, major field of study, participation in officially recognized activities and sports, weight and height (if members of athletic teams) and degrees and awards received will be released in our local newspapers.
- Sherburne-Earlville Central School will use "student directory information" in its yearbooks, on school bulletin boards, internet web pages, educational channel, school newspapers, school newsletters, and media outlets (newspaper, radio, TV stations). Captions accompanying photographs on internet web pages will not identify students by name.
- As a parent, legal guardian, or student over the age of 18, you have the right to refuse the release of student directory information, otherwise known as "opting out."

#### **Pesticide Application Notification**

New York State Education Law Section 409-H, effective July 1, 2001, requires all public and nonpublic elementary and secondary schools to provide written notification to all persons in parental relation, faculty and staff regarding the potential use of pesticide periodically throughout the school year.

The Sherburne-Earlville Central School District is required to maintain a list of persons in parental relation, faculty and staff who wish to receive a 48hour prior written notification of certain pesticide applications. The following pesticide applications are not subject to prior notification requirements: a school remains unoccupied for a continuous 72-hours following an application; anti-microbial products; nonvolatile rodenticides in tamper resistant bait stations in areas inaccessible to children; nonvolatile insecticidal baits in tamper resistant bait stations in areas inaccessible to children; silica gels and other nonvolatile ready-to-use pastes, foams, or gels in areas inaccessible to children; boric acid and disodium octaborate tetrahydrate; the application of EPA designated biopesticides; the application of EPA designated exempt materials under 40CFR152.25; the use of aerosol products with a directed spray in containers of 18 fluid ounces or less when used to protect individuals from an imminent threat from stinging and biting insects including venomous spiders, bees, wasps, and hornets.

In the event of an emergency application necessary to protect against an imminent threat to human health, a good faith effort will be made to supply written notification to those on the 48-hour notification list.
