# We're doing great things at SECS D, but the best is yet to come!



Spring is finally here, but the Sherburne-Earlville Central School District had quite a winter!

Congratulations are in order for several SECS D students and programs as we continue to show that, when given the opportunities, we can compete with any students from any districts across the state.

Winter highlights include all seven of our Odyssey of the Mind squads qualifying for the New York State Championships, five FFA members reaching Substate competition, four SEHS students earning berths to the New York State SkillsUSA Leadership and Skills Championships, all three of our Robotics teams receiving World Championship invitations, and a third-place finish for our HS Foods classes in the New York Agriculture in the Classroom's Top Cut Beef Competition.

The majority of our winter sports programs competed in postseason events, too, with two wrestlers – sophomore co-captain **Landon Andrade** and junior **Selina Moore** – proudly representing the Marauders in New York State Public High School Athletic Association tournaments. We also inducted 26 newcomers into our National Honor Society, produced a top-notch Addams Family musical for the community, and recently celebrated the academic achievements of the Top 10 seniors in our Class of 2023.

Our top three seniors in particular – Valedictorian **Grace Todd-Rogers**, Salutatorian **Anna Fern** and **Jordan Winton** – have been long-time best friends. The authenticity and sincerity with which they supported one another in receiving that recognition at a recent Board of Education meeting was very powerful. You know you have a true friend when you have something amazing happen and they're there cheering you on and celebrating your accomplishments.

We've heard from students at all levels that they want even more hands-on opportunities, which is why we're excited about developing STEAM initiatives in our elementary, middle and high schools, and adding new programs to enhance learning in the fields of robotics, coding, drones, building trades and computer science, to name a few.

SECS D also is entering the design phase of our Capital Project, which voters approved by more than a 2-to-1 margin in December. Sub-committee planning meetings focused on performing arts, classroom designs and our athletic complex are underway. # S-E honors Eaves with book project



A packed library and a bunch of new books for the “kiddos” . . . Dana Eaves would have loved this!

The Sherburne-Earlville Elementary School Library always was a special place for Dana, but on March 17, it became a special place because of her.

SECS D faculty and staff spent part of their professional development day lining the library aisles for the unveiling of the “The Dana Eaves Book Project,” a unique book collection in memory of the beloved SEES Kindergarten teacher who unexpectedly passed away in January 2022.

“Dana loved her kids . . . and she loved being here every day,” said former SEES Principal John Douchinsky, Dana’s building administrator during the early years of her lengthy teaching career. “She put her heart and soul into her classroom, her students and her instruction. We were very fortunate to have had her here with us.

“It’s very appropriate that this collection is dedicated in her honor,” he continued. “Just as she was a part of the school when she was here, she will always remain part of our school community through this collection.”

Dana’s family collaborated with the Sherburne-Earlville Teachers’ Association, the District and community members to select books that would inspire Kindergarten students to be lifelong readers.

“This book collection is a wonderful addition to the library,” former SECS D Superintendent Gayle Hellert said. “It celebrates not only Dana’s professional career of over 20 years, but what she means to Sherburne-Earlville.”

Dana’s mother and father were among the special guests, as were several others who were close to Dana. One in particular was SEES Special Education Teacher Kathryn Barth, who spoke fondly of her good friend.

“Dana was one of the kindest people . . . so giving and loving. She was so generous and had a kind heart,” she said. “Dana taught me to find joy every day – even if it was a cheese dog in the cafeteria. She found joy every day, and that’s very important.”

Printed flyers for the event – which featured a video tribute and lots of cookies (Dana’s favorite treat) – read as follows: “Dana Eaves was a beautiful, vibrant young woman who was full of life and love. She lost her life much too soon in January 2022. Dana was a much-loved family member, teacher, and friend. She loved teaching her kindergarten ‘kiddos’ and was especially dedicated to childhood literacy, always striving to ensure her young students developed a love for books and reading.

To honor Dana and to keep her memory alive, a children’s book collection has been created in her name. Built through generous donations from community near and far, the collection will enrich the reading lives of children at Sherburne-Earlville Elementary School for years to come. Each book in the collection carries this dedication: Book Collection Inspired by Dana Eaves To Promote the Love of Reading for all ‘Kiddos’.

## World Class Robotics!

All three Sherburne-Earlville Robotics teams earned invitations to the VEX World Championships following competition at the 10th annual Northern New York State VEX High School Championships, which took place March 11 at The Oncenter in Syracuse.

The Burninators 13460C – **Brayden Smith, Amon Van Alst, Ryan Solloway**, robot Trogdor, and coach Wesley Macker – reached the March 11 state championship final to earn an automatic berth to the World Championships, scheduled for April 25-May 4 in Dallas, Texas.

The Burninators and alliance partner Revenge of the Titans 7157A fell, 2-1, in the state championship to the Robo Hornets 53999P of Harpursville and the Fire Breathing Marshmallows 8214C of Onondaga. World berths are awarded to all state finalists, regardless of championship results.

The SE Mecharauders 13460X – **Jackson Barker, Aaron Romanowski**, robot R2-D2, and coach Jonathan Ryan – also automatically qualified for the World Championships by winning the Northern NY Excellence Award at the middle-school level.

The Slightly Below Room Temperaturinators 13460Y – **Braden Lewis, Avery Solloway**, and robot Trogwindow – also competed at the middle-school level at the Northern NY championships and qualified for Worlds based on performance.

Please note that the SBHC at S-E works with primary healthcare providers to see patients as soon as possible. Regular hours of operation at S-E are 8 a.m.-4 p.m. Monday-Thursday and 7:30 a.m.-3:30 p.m. Friday (when school is in session).

The SBHC at S-E also offers dental-hygiene and mental-health services, as well as flu and COVID-19 vaccines/boosters at no cost to students enrolled in the SBHC program.

## Welcome to the #SETeam!

SECSO welcomes Oxford native Benjamin Lewis to the #SETeam as our Coordinator of Transportation and Maintenance.

Lewis has served in the U.S. Army for the last 25 years, most recently as an Operations Officer in charge of the day-to-day operations for more than 4,400 people in Syracuse. He joins SECSO through the Department of Defense's career skills program, which is designed to help service members with the transition to non-military careers.

Lewis will retire from the Army with a Chief Warrant Officer 4 rank later this year and referred to his new position



at SECSO as his "next career and last career."

"I'm vested and I want Sherburne-Earlville to continue to do well because my kids go here, my wife works here, and now I work here," said Lewis, who lives in Earlville with his wife of 18 years, Jessica, and their five children. Jessica teaches third grade at S-E Elementary School, and all of their children (ages 9-16) are enrolled at SECSO.

"It's imperative that we succeed," he continued, "but I don't think there's really a chance of failure because we have a solid crew in the transportation department as well as buildings and grounds."

Sherburne-Earlville Central School District residents ages 21-and-older are invited to test drive a school bus during our Transportation Department's School Bus Driver Recruitment Event, which runs from 9 a.m. - noon April 15.

Participants will have the opportunity to test drive one of our well-maintained buses – among the safest vehicles on the road today\* – on a pre-established campus course with the help of an experienced SECSO driver.

SECSO is seeking substitute bus drivers/attendants and offers training to candidates for employment. Please note that a CDL is not required to simply test drive a school bus or apply for a bus driver position.

Refreshments (coffee, donuts, fruit) will be provided during our School Bus Driver Recruitment Event, and members of our Transportation Department will be available to answer any questions.

Driving a school bus is easier than you might think and is perfect for parents/guardians looking to earn money without sacrificing time with their families. 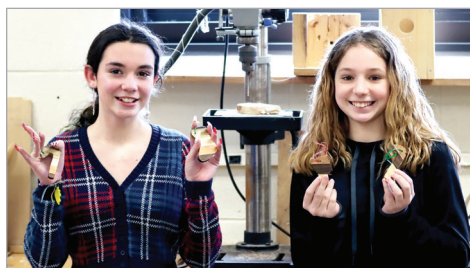

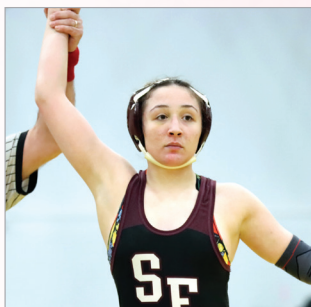
## Second in the state!

Congratulations to SEHS junior **Selina Moore** on her runner-up finish during the first New York State Public High School Athletic Association Girls Wrestling Invitational on January 27 at Onondaga Community College!

Second-seeded Selina faced No. 1 seed Zoey Lints, a senior from Duanesburg-Schoharie, in the first state championship match of the night. Selina went the distance but fell, 7-3, in the 138-pound title bout.

Zoey pinned her first three opponents in 31 seconds or less to reach the championship match against Selina, who advanced with an 11-6 semifinal decision over third-seeded Penfield senior Ellanora Bode. Selina also pinned Chenango Forks freshman Emily Sullivan (58 seconds) in the quarterfinals and junior Alivia Ortiz of Ravena-Coeymans-Selkirk (2:19) in her opening match.

S-E's **Pasley French** (94 pounds), **Gabbi Naylor** (107) and **Leonora Serrano** (114) also competed in the inaugural NYSPHSAA Girls Wrestling Invitational. Greg and Garrett DuVall – our varsity and junior varsity wrestling coaches, respectively – accompanied and coached the quartet at states.



## Junior swimmer breaks school record!



Congratulations to SEHS junior swimmer **Amon Van Alst** for breaking a school record in one event and winning another during the Section III Class C Championships in February at Syracuse Nottingham!

Amon placed second in the 200-yard individual medley in 2 minutes, 9.43 seconds, beating the school record of 2:10.38 set by **Dillon Moyer** in 2013. He also placed first in the 500 freestyle in 5:13.21 – more than 20 seconds faster than his seed time – to become the first S-E boys swimmer to win a sectional class title since Gavin Lopata took the 200 freestyle in 2015.

Amon went on to finish third in the 500 free (5:11.92) during the overall Section III Championships on February 17 at Nottingham. He also competed for the Marauders' 200 and 400 free relay teams, which both featured personal-best split times for all members.

**Indoor Track and Field:** Senior **Lily Stoddard** achieved a personal record of 32 feet, 7.25 inches in the weight throw to place 14th during the Section III State Qualifiers on February 15 at Onondaga Community College. Additionally, Lily (shot put, weight throw), **Aidan Camenga** (triple jump), and **Avery Solloway** (high jump) won Center State Conference titles January 26 at Utica University.

**Bowling:** Senior **Jacob Jenkins** finished his fifth season as a varsity bowler February 16 during the Section III Individual Shootout at Pin-O-Rama Lanes in Utica. One of 42 competing for just two spots on the Section III Composite Team, Jacob averaged 171 over six games.

**Basketball:** S-E's boys and girls varsity teams reached sectionals this season. The boys lost their first-round game and finished 5-16. The girls (10-12) made it to the second round but lost in overtime.



## Wrestler Andrade goes 3-2 at states!

Congratulations to sophomore wrestling co-captain **Landon Andrade** for winning his first match February 24 en route to a 3-2 record at the New York State Public High School Athletic Association Division II Championships at MVP Arena in Albany!

Landon opened his first state-tournament appearance with a pin of John Glenn senior Melkin Alfaro-Chavez 39 seconds into the second period at 285 pounds. He lost his next match to the eventual 285-pound D-II state champion, second-seeded Bolivar-Richburg senior Trent Sibble, who pinned Landon with 4 seconds to go in the second period.

Landon followed with a 1:27 pin of Ogdensburg's Archie Green in wrestlebacks, then earned an 8-2 victory by decision against Locust Valley's Charles Kelly to reach the second day of wrestlebacks on February 25. His season ended with a loss by pin (3:34) to Adirondack's Colin White, who finished fourth in the state after losing the third-place match by injury default.

## Annual Notice – AHERA

In 1986, Congress passed the Asbestos Hazard Emergency Response Act (AHERA). This required schools to be inspected to identify any asbestos-containing building materials. All Sherburne-Earlville School buildings were inspected and suspected materials were sampled to be tested and rated according to condition and potential hazard.

Every three years, the Sherburne-Earlville Central School District is required to be re-inspected to determine if any known or suspected asbestos-containing building materials (ACBM) has changed and to make recommendations on managing or removing the ACBM.

The law further requires an asbestos-management plan be developed to monitor any known or suspected ACBM. The plan has several ongoing requirements: This notification letter announcing the availability of the management plans for anyone to review upon request, training of the support staff about asbestos and how to deal with it, noti-

fying short-term workers such as sub-contractors of the locations of any known or suspected ACBM, and posting of warning signs adjacent to locations of known or suspected ACBM. The designated asbestos coordinator conducts a six-month inspection of areas of the buildings where known or suspected ACBM are located to assure they remain in good condition.

It is the intention of the Sherburne-Earlville Central School District to comply with all federal and state regulations controlling asbestos and to take whatever steps are necessary to ensure students and employees a healthy and safe environment in which to learn and work.

You are welcome to review a copy of the asbestos-management plan upon request. ## Annual Notice – Child Find

The Sherburne-Earlville Central School District recognizes its responsibility to provide a free and appropriate public education to eligible students with disabilities within its geographical boundaries. The District has a "child find" process that is designed to locate, identify and evaluate children with disabilities residing within its geographical boundaries, preschool through grade 12, or through age 21 if they have not received a high school diploma.

If you know a child who lives within SECSD's boundaries and attends school in the District who may be in the need of special education and/or related services, please contact the District's Director of Special Education for further information regarding the referral and evaluation process. If the student is a school-age student who attends a private school (non-public) that is not located within SECSD's geographical boundaries, the student may need to be referred to the

school district in which the non-public school is located to receive services during the regular school year. Please contact that school district for information regarding time deadlines for requests for services.

The District's Child Find process extends to students with physical or mental impairments that substantially limit a major life activity. Such students may be eligible for services or accommodations pursuant to Section 504 of the Rehabilitation Act. Section 504 is a Federal civil rights statute that prohibits discrimination against persons with disabilities and programs receiving Federal financial assistance. Please contact your child's building principal for more information regarding Section 504 eligibility and services.

## Annual Notice—DASA

The Dignity for All Students Act prohibits harassment and/or discrimination of students by employees or other students on school property or at school functions based upon a student's actual or perceived race, color, weight, national origin, ethnic group, religion, religious practice, disability, sexual orientation, gender or sex.

## Annual Notice – FERPA

The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a Federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education.

FERPA gives parents/guardians certain rights with respect to their children's education records. These rights transfer to the student when they reach the age of 18 or attend a school beyond the high school level. Students to whom the rights have transferred are "eligible students."

Parents/guardians or eligible students have the right to inspect and review the student's education records maintained by the school. Schools are not required to provide copies of records unless, for reasons such as great distance, it is impossible for parents/guardians or eligible students to review the records. Schools may charge a fee for copies.

Parents/guardians or eligible students have the right to request that a school correct records they believe to be inaccurate or misleading. If the school decides not to amend the record, the parent/guardian or eligible student then has the right to a formal hearing. After the hearing, if the school still decides not to amend the record, the parent/guardian or eligible student has the right to place a statement with the record setting forth their view about the contested information.

Generally, schools must have written permission from the parent/guardian or eligible student to release any information from a stu-

dent's education record. However, FERPA allows schools to disclose those records, without consent, to the following parties or under the following conditions (34 CFR § 99.31):

- School officials with legitimate educational interest;
- Other schools to which a student is transferring;
- Specified officials for audit or evaluation purposes;
- Appropriate parties in connection with financial aid to a student;
- Organizations conducting certain studies for or on behalf of the school;
- Accrediting organizations;
- To comply with a judicial order or lawfully issued subpoena;
- Appropriate officials in cases of health and safety emergencies; and
- State and local authorities, within a juvenile justice system, pursuant to specific State law.

Schools may disclose, without consent, "directory" information such as a student's name, address, telephone number, date and place of birth, honors and awards, and dates of attendance. However, schools must tell parents/guardians and eligible students about directory information and allow them a reasonable amount of time to request that the school not disclose directory information about them. Schools must notify parents and eligible students annually of their rights under FERPA. The actual means of notification (special letter, inclusion in a PTA bulletin, student handbook, or newspaper article) is left to the discretion of each school.02.

## FERPA Rights

The Family Educational Rights and Privacy Act (FERPA) affords parents/guardians and students who are 18 years of age or older ("eligible students") certain rights with respect to the student's education records. These rights are:

- The right to inspect and review the student's education records within 45 days after the day the Sherburne-Earlville Central School District receives a request for access. Parents/guardians or eligible students who wish to inspect their child's or their education records should submit to the Superintendent of Schools, School Principal or Guidance Counselor a written request that identifies the records they wish to inspect. The school official will make arrangements for access and notify the parent/guardian or eligible student of the time and place where the records may be inspected.
- The right to request the amendment of the student's education records that the parent/guardian or eligible student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA. Parents/guardians or eligible students who wish to ask SECSO to amend their child's or their education record should write the Superintendent of Schools, School Principal or Guidance Counselor, clearly identify the part of the record they want changed, and specify why it should be changed. If the school decides not to amend the record as requested by the parent/guardian or eligible student, the school will notify the parent/guardian or eligible student of the decision and of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent/guardian or eligible student when notified of the right to a hearing.
- The right to provide written consent before the school discloses personally identifiable information (PII) from the student's

education records, except to the extent that FERPA authorizes disclosure without consent. One exception, which permits disclosure without consent, is disclosure to school officials with legitimate educational interests. A school official typically includes a person employed by the school or school district as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel) or a person serving on the school board. A school official also may include a volunteer, contractor, or consultant who, while not employed by the school, performs an institutional service or function for which the school would otherwise use its own employees and who is under the direct control of the school with respect to the use and maintenance of PII from education records, such as an attorney, auditor, medical consultant, or therapist; a parent/guardian or student volunteering to serve on an official committee, such as a disciplinary or grievance committee; or a parent/guardian, student, or other volunteer assisting another school official in performing their tasks. A school official typically has a legitimate educational interest if the official needs to review an education record to fulfill their professional responsibility.
