Catherine's story about how the SBHC creatively utilized telehealth in 2020—when schools across the country were closed because of the COVID-19 pandemic—to deliver virtual dental care and education for students to improve their dental hygiene won one of two third-place prizes.

The New York School-Based Health Foundation awarded two first-, second- and third-place prizes in its Telehealth Story Contest based on story content and presentation, as well as creativity, measurable impact, and replicability by other SBHCs.

SECSD thanks the Madison County Sheriff's Department for helping our buses safely bring students to school April 27 as part of New York State's Operation Safe Stop Education and Enforcement Day.

Officers met SECSD driver John Keller and his "Whale Bus" riders at 7:15 a.m. in Earlville and escorted some of our most important stakeholders along the route to campus. Illegal passes while the red school bus lights are flashing did happen on occasion this school year, but no incidents were reported April 27.

Law enforcement officers around the state board school buses and follow selected routes in marked and unmarked patrol units on Operation Safe Stop Education and Enforcement Day. Tickets are issued to any motorist who passes a stopped school bus while the red lights are flashing, and violations are reported to a central command post. Final figures on violations are available to state and local officials, as well as the media.



Congratulations to the recipients of the 2023 Ferdinand and Emilie Maltzan Awards, who were honored during Sherburne-Earlville High School's 56th Graduation Ceremony on June 24 at Marauder Stadium. These prestigious awards, estab-

lished by Adeline Maltzan in memory of her courageous, hardworking parents, have been given annually since 1997 to the 10 SEHS graduating seniors with the highest overall academic averages.

Leslie Wedge (far left) and his sister Susan Davidson (far right) proudly presented the 2023 Ferdinand and Emilie Maltzan Awards on behalf of their late aunt Adeline to (left to right) **Rylan Sigman, Cody Lawson, Ruby Rivenburgh, Emily Lawrence, Trinity Thornton, Tighe Dean, Lily Stoddard, Jordan Winton**, Salutatorian **Anna Fern**, and Valedictorian **Grace Todd-Rogers**. Each award-winner earned a scholarship in the amount of \$1,740.

Through a provision in her will, Adeline established a \$250,000 fund with the Central New York Community Foundation to reward graduates for their academic achievements and to encourage students everywhere to maintain the highest standards throughout their lives. Now in its 27th year, the Ferdinand and Emilie Maltzan Scholarship Fund has awarded more than \$476,000 to students. Adeline was Sherburne High School's Class of 1943 valedictorian, who learned from her parents—immigrants who married in 1907 before moving from New York City to Sherburne—that responsibility and hard work were the keys to success in academics and life. The second youngest of 10 children who grew up during the Great Depression and two world wars, Adeline went on to graduate from Syracuse University magna cum laude, then taught high school science while earning a Master's Degree in Education. She later became the head of her science department and then launched a career as an allergy technician, retiring from the latter in 1984.

Adeline remained active throughout her retirement, supporting the Syracuse Symphony and volunteering as an adult reader at Rockwell Elementary School in Nedrow. Before succumbing to cancer on January 4, 1996, she took an important step toward assuring her philosophy and the legacy of her parents would live on by establishing the Ferdinand and Emilie Maltzan Scholarship Fund.



Marshall was simply in awe when news crews, photographers and throngs of fans greeted him at the Landmark's entrance while his name and movie title flashed in the giant, bright lights of the marquee. The event set a Make-A-Wish event record for attendance (1,700+) and helped Marshall raise more than \$22,000 on his Wish Heroes donation page, more than doubling his goal of raising \$10,000 to support the dreams of other Make-A-Wish Kids. Crouch joins Clinton Regatta Hall of Fame!



Congratulations to recently retired S-E teacher Holly Crouch on her induction into the General Clinton Canoe Regatta Hall of Fame!

Retired Air Force Master Sergeant and Sherburne resident Crouch was one of seven members in the Class of 2023, which was inducted May 27 during the General Clinton Hall of Fame Dinner at General Clinton Park in Bainbridge.

Two days later, Crouch joined Cameron Cummings, Timothy Henning and Richard Neugebauer as "The Foursomes" in the Regatta's C-4 Stock Endurance Race as she completed her 39th 70-mile race down the Susquehanna River, from Cooperstown's Otsego Lake to Bainbridge's General Clinton Park.

The Class of 2023 featured paddlers Crouch, Alec Davis, Roger Henry and Terry Kent, along with contributors Ray Darling and the husband-wife duo of Gary and Tracy Smith. They were the 10th Hall of Fame class – inductions started in 2012 but COVID-19 canceled the Regatta and related events in 2020 and 2021 – and brought the Hall's membership to 72.

Crouch is the definition of a trailblazer. She started the Clinton's C-1 women's division after paddling in the open men's division for three years and has competed all over the northern hemisphere. Crouch has a number of top-three placings in the C-1 and C-2 women's events and participated in the inaugural C-4 mixed race. Her 39 Clinton finishes translate to 2,730 miles in the event, tied for 12th all-time in the prestigious 700-Mile Club.

Crouch also serves as an advisory board member for U.S. Veterans' Rowing & Kayaking (*New York Division Program Coordinator*). In addition to the Clinton, Crouch competed in the Yukon River Quest (500 miles) at the end of June and planned to participate in the 120-mile AuSable River Canoe Marathon in Michigan at the end of July, the U.S. Nationals in August, and the 90-mile Adirondack Canoe Classic in September.

ES students collect 'Socks for Soldiers'





Athletic Hall of Fame welcomes two!

Sherburne-Earlville honored its Athletic Hall of Fame's Class of 2023-wrestling coach Richard "Pete" Hausrath and three-sport standout Kelly (Cooman) Kingsburyon June 21, 2023, during its year-end Athletics Awards Ceremony on campus.



Richard "Pete" Hausrath: The former Sherburne-Earlville wrestling coach, athletics administrator, and referee earned back-to-back Section IV Wrestling Coach of the Year honors in 1978 and 1979. He is a member of the New York chapter of

the National Wrestling Hall of Fame and has dedicated more than five decades to the sport as both a competitor and a coach at various levels. Pete wrestled for Massapequa High School before joining the Iowa State University wrestling team, which won the NYAC National Championship in the early 1960s. The South New Berlin resident is a retired teacher (40 years) who currently serves Unadilla Valley as an assistant wrestling coach. Also a two-time National Freestyle/Greco Roman coach, camp director and guest clinician, he has trained thousands of youth wrestlers in New York, Iowa, North Dakota, and Minnesota.



Kelly (Cooman) Kingsbury: The Franklin resident and 2001 SEHS graduate set school records in field hockey, track and field, and girls basketball. Her 120 field hockey points from 1998-2000 ranked fifth in Section IV. During the same span,

she amassed 47 goals and 26 assists. A First Team all-state selection in 2000, Kelly also set single-season program records for points (41), goals (18) and assists (16). She graduated from Hartwick College in 2005 as the program's top points producer (164) and goal scorer (68), and ranked third in all-time assists (28). A four-time all-state selection in college, Kelly led the Empire 8 Conference in scoring three times and helped the Hawks to the E8 title and an NCAA Tournament appearance in 2004. A 2012 inductee into Hartwick's Athletics Hall of Fame, Kelly was a First Team All-American, ECAC and Empire 8 Player of the Year, First Team Empire 8, All-Region, NYSWCAA Scholar-Athlete, and Hartwick Athlete of the Year. Her 36 point-game for S-E girls basketball in 2000 was a program record at the time, and she excelled in track and field (pole vault, 400-meter relay). Kelly served Hartwick as an assistant field hockey coach for three seasons before becoming SUNY Oneonta's head coach in 2008. She is O-State's all-time winningest coach, with 127 victories.

Stoddard signs with D-I Binghamton



Sherburne-Earlville High School celebrated Lily Stoddard on June 7 as the Division I-bound studentathlete signed a National Letter of Intent to compete for the Binghamton University Bearcats track and field team!

Flanked by her father and mother, Thomas and Lynda, Lily signed a ceremonial NLI on stage at the MS/HS Auditorium in front of classmates, teammates, administrators and staff members. An impromptu photo session followed remarks by coaches Will Slentz, Wes Macker and Athletic Director Brad Perry.

Lily, who finished third in the discus during the Section III Division 2 State Qualifiers, ranked fourth academically in our Class of 2023 and plans to major in biology at BU. She also plans to enter the Army as an officer to train to be a medic and then attend medical school to become a surgeon.

Lily is the first SEHS student-athlete to join a Division I sports program since 2016 graduate Jack Buell, who wrestled for Army West Point after winning S-E's first state championship in 47 seasons as a senior. Other SEHS graduates who have competed at the D-I level since the turn of the century are Austin Jasper (Tiffin University football), Natalie Plesniarski (Colgate University field hockey), and Mike Bagnall (Syracuse University men's rowing).

Two compete in state track qualifiers!



Congratulations to Aidan Camenga and Lily Stoddard on reaching the Section III Track and Field State Qualifiers on June 1 at Cicero-North Syracuse.

Aidan finished his junior season with a third-place time of 58.44 seconds – his season best – in the 400-meter hurdles and also placed seventh in the triple jump at 40 feet. Lily completed her senior season with a discus throw of 100 feet, good for third place.

Aidan earned his 400 hurdles spot in the state qualifiers by placing second in 58.51 during the Section 3 Class C-1 Championships May 23 at Little Falls. He qualified in the triple jump

with a seed distance of 41 feet, 9.75 inches. Lily made it to the state qualifiers with a seed distance of 106-11 in the discus. Headed to Division I Binghamton University in the fall, Lily took third at the Section 3 C-1 meet at 96-1.

In addition to these individual achievements, the NYSPHSAA recognized our boys and girls track and field teams as Scholar-Athlete Teams for the 2023 spring sports season. To receive NYSPHSAA Scholar-Athlete accolades, at least 75 percent of a team's roster must maintain a scholastic average of 90 or better.


Student-athletes ages 6-19 from all over the state competed in the NYWAY Girls State Championship, which featured 15 weight classes in each age-group division.

Annual Notice – AHERA

In 1986, Congress passed the Asbestos Hazard Emergency Response Act (AHERA). This required schools to be inspected to identify any asbestos-containing building materials. All Sherburne-Earlville School buildings were inspected and suspected materials were sampled to be tested and rated according to condition and potential hazard.

Every three years, the Sherburne-Earlville Central School District is required to be re-inspected to determine if any known or suspected asbestos-containing building materials (ACBM) has changed and to make recommendations on managing or removing the ACBM.

The law further requires an asbestos-management plan be developed to monitor any known or suspected ACBM. The plan has several ongoing requirements: This notification letter announcing the availability of the management plans for anyone to review upon request, training of the support staff about asbestos and how to deal with it, notifying short-term workers such as sub-contractors of the locations of any known or suspected ACBM, and posting of warning signs adjacent to locations of known or suspected ACBM. The designated asbestos coordinator conducts a sixmonth inspection of areas of the buildings where known or suspected ACBM are located to assure they remain in good condition.

It is the intention of the Sherburne-Earlville Central School District to comply with all federal and state regulations controlling asbestos and to take whatever steps are necessary to ensure students and employees a healthy and safe environment in which to learn and work.

Annual Notice – Child Find

The Sherburne-Earlville Central School District recognizes its responsibility to provide a free and appropriate public education to eligible students with disabilities within its geographical boundaries. The District has a "child find" process that is designed to locate, identify and evaluate children with disabilities residing within its geographical boundaries, preschool through grade 12, or through age 21 if they have not received a high school diploma.

If you know a child who lives within SECSD's boundaries and attends school in the District who may be in the need of special education and/or related services, please contact the District's Director of Special Education for further information regarding the referral and evaluation process. If the student is a school-age student who attends a private school (non-public) that is not located within SECSD's geographical boundaries, the student may need to be referred to the school district in which the non-public school is located to receive services during the regular school year. Please contact that school district for information regarding time deadlines for requests for services.

The District's Child Find process extends to students with physical or mental impairments that substantially limit a major life activity. Such students may be eligible for services or accommodations pursuant to Section 504 of the Rehabilitation Act. Section 504 is a Federal civil rights statute that prohibits discrimination against persons with disabilities and programs receiving Federal financial assistance. Please contact your child's building principal for more information regarding Section 504 eligibility and services.

Annual Notice—DASA

Annual Notice – FERPA

The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a Federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education.

FERPA gives parents/guardians certain rights with respect to their children's education records. These rights transfer to the student when they reach the age of 18 or attend a school beyond the high school level. Students to whom the rights have transferred are "eligible students."

Parents/guardians or eligible students have the right to inspect and review the student's education records maintained by the school. Schools are not required to provide copies of records unless, for reasons such as great distance, it is impossible for parents/guardians or eligible students to review the records. Schools may charge a fee for copies.

Parents/guardians or eligible students have the right to request that a school correct records they believe to be inaccurate or misleading. If the school decides not to amend the record, the parent/ guardian or eligible student then has the right to a formal hearing. After the hearing, if the school still decides not to amend the record, the parent/guardian or eligible student has the right to place a statement with the record setting forth their view about the contested information.

Generally, schools must have written permission from the parent/ guardian or eligible student to release any information from a stu-

FERPA Rights

The Family Educational Rights and Privacy Act (FERPA) affords parents/guardians and students who are 18 years of age or older ("eligible students") certain rights with respect to the student's education records. These rights are:

- The right to inspect and review the student's education records within 45 days after the day the Sherburne-Earlville Central School District receives a request for access. Parents/guardians or eligible students who wish to inspect their child's or their education records should submit to the Superintendent of Schools, School Principal or Guidance Counselor a written request that identifies the records they wish to inspect. The school official will make arrangements for access and notify the parent/guardian or eligible student of the time and place where the records may be inspected.
- The right to request the amendment of the student's education records that the parent/guardian or eligible student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA. Parents/guardians or eligible students who wish to ask SECSD to amend their child's or their education record should write the Superintendent of Schools, School Principal or Guidance Counselor, clearly identify the part of the record they want changed, and specify why it should be changed. If the school decides not to amend the record as requested by the parent/guardian or eligible student, the school will notify the parent/guardian or eligible student of the decision and of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent/guardian or eligible student when notified of the right to a hearing.
- The right to provide written consent before the school discloses personally identifiable information (PII) from the student's

dent's education record. However, FERPA allows schools to disclose those records, without consent, to the following parties or under the following conditions (34 CFR § 99.31):

- School officials with legitimate educational interest;
- Other schools to which a student is transferring;
- Specified officials for audit or evaluation purposes;
- Appropriate parties in connection with financial aid to a student;
- Organizations conducting certain studies for or on behalf of the school;
- Accrediting organizations;
- To comply with a judicial order or lawfully issued subpoena;
- Appropriate officials in cases of health and safety emergencies; and
- State and local authorities, within a juvenile justice system, pursuant to specific State law.

Schools may disclose, without consent, "directory" information such as a student's name, address, telephone number, date and place of birth, honors and awards, and dates of attendance. However, schools must tell parents/guardians and eligible students about directory information and allow them a reasonable amount of time to request that the school not disclose directory information about them. Schools must notify parents and eligible students annually of their rights under FERPA. The actual means of notification (special letter, inclusion in a PTA bulletin, student handbook, or newspaper article) is left to the discretion of each school.02.

education records, except to the extent that FERPA authorizes disclosure without consent. One exception, which permits disclosure without consent, is disclosure to school officials with legitimate educational interests. A school official typically includes a person employed by the school or school district as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel) or a person serving on the school board. A school official also may include a volunteer, contractor, or consultant who, while not employed by the school, performs an institutional service or function for which the school would otherwise use its own employees and who is under the direct control of the school with respect to the use and maintenance of PII from education records, such as an attorney, auditor, medical consultant, or therapist; a parent/guardian or student volunteering to serve on an official committee, such as a disciplinary or grievance committee; or a parent/guardian, student, or other volunteer assisting another school official in performing their tasks. A school official typically has a legitimate educational interest if the official needs to review an education record to fulfill their professional responsibility.

• The right to file a complaint with the U.S. Department of Education concerning alleged failures by SECSD to comply with the requirements of FERPA.
